The following constitutes the knowing and voluntary election and stipulation of the entity named below ("Company" or "Opt-In Defendant") to join as a Settling Defendant under the Consent Judgment previously entered by the Court in Brimer v. The Company has not provided compliant Proposition 65 warnings in conjunction with the sale or use of all such Covered Products in California at all times during the Relevant Period.

The Company has not conducted a risk or exposure assessment for all Covered Products within each separate category checked above firmly establishing that the use of such Covered Products will result in an exposure in an amount less than that deemed permissible in 22 Cal. ## **Declaration of Robert Donovan**

I, Robert Donovan, hereby declare:

- 1. I am Chief Financial Officer of Blue Diamond Growers, which operates Blue Diamond Growers' Store at its operating locations in this state.
- 2. I am informed and advised of the fact that Blue Diamond Growers received a 60-Day Notice of Violation on September 2, 2005 from Russell Brimer, a private citizen acting under authority of Proposition 65, alleging that ceramic mugs containing lead were sold without a clear and reasonable warning as required by law.
- 3. Upon reasonable and good faith investigation, Blue Diamond Growers has determined that its sales of such ceramic mugs was less than 500 units in 2004. This determination is supported by supplier invoice information which indicates that 288 Blue Diamond logo mugs (#7170; #000989) were provided to Blue Diamond Growers by its supplier in 2004 and that several cases remain in inventory. In addition, many of the mugs that are out of inventory were used internally and otherwise not sold to the public.
- 4. Based on this information assembled upon diligent investigation by Blue Diamond Growers personnel, which I am informed of and believe, I can attest to the fact that Blue Diamond Growers' Stores sold less than 500 of the Blue Diamond mugs at issue in this matter.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
