24 Both parties agreed to settle the matter pursuant to the
25 following terms:

- 26 1) Injunctive relief to include C.K Worldwide will place
27 clear and reasonable Proposition 65 warnings on all
28 of its cold wire feeders and Tig torches that include
tips (those sold without tips will not require a

Worldwide will take reasonable steps to ensure that the warnings are placed on the products as soon as is commercially reasonable.

2) C.K. World wide will pay to Michael DiPirro the total sum of \$9,000, to be apportioned as \$7,000 for pre-notice investigation fees and costs, \$1,000 civil penalty with 75% to be sent to the State of California, and \$1,000 attorney fees. C.K. will send a check for the entire amount made payable to "The Law Offices of David Bush." *within 14 days from the date this order is signed. DEH/m*

IT IS HEREBY ORDERED that judgment be entered in accordance with the terms of this order.




