EXHIBIT A

AGREEMENT

Dated as of July 12, 1993

WHEREAS:

As You Saw ("AYS") is a not-for-profit public interest corporation whose purpose is dedicated to promoting consumer awareness, protecting the environment, and improving human health; and

Conopco, Inc. is a corporation doing business, inter alia, as Elizabeth Arden and Chesebrough-Pond's USA (hereinafter collectively "Conopco"), that currently manufactures nail enamel products containing the chemical toluene, which products are sold in retail stores; and

On January 1, 1991, toluene was listed by the State of California as a chemical known to cause birth defects or other reproductive harm, pursuant to California Health & Safety Code § 25249.8; and

A list of the nail enamel products containing toluene which Conopco has manufactured for retail sale in California since January 1, 1992, is provided in the attached Appendices A and B (collectively the "Products"); and

On November 18, 1992, AYS served Conopco with a document entitled "60-Day Notice" which provided Conopco with notice that it was allegedly in violation of California Health & Safety Code § 25249.6, for failing to warn purchasers and individuals using the Products that certain nail enamel products Conopco sells in California expose users to toluene, a chemical known by the State of California to cause birth defects or other reproductive harm; and

On April 5, 1993, AYS filed a complaint against Conopco entitled As You Sow v. Revlon Inc. et al., Case No. 950766, in San Francisco Superior Court, alleging violations of California Health & Safety Code § 25249.6 (hereinafter "Prop 65") and Business & Professions Code § 17200 (hereinafter the "Action").

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. Nothing in this Agreement shall be construed, and Conopco expressly does not intend to imply, any admission by Conopco as to any fact, finding, issue of law, or violation of law, nor shall compliance with this Agreement constitute or be construed as an admission by Conopco of any fact, finding, conclusion, issue of law, or violation of law. However, this paragraph shall not diminish or otherwise affect the obligation, responsibilities, and duties of Conopco under this Agreement.
2. Conopco agrees not to ship for sale (or cause to be shipped for sale) any of the Products set forth in the attached Appendix A into the State of California after October 1, 1993 unless such products have been reformulated so as to eliminate the presence of toluene as an intended ingredient; provided that, Conopco may ship into the State of California those specific products set forth in the attached Appendix B in their current formulation after October 1, 1993, but not after December 31, 1993.
3. If Conopco fails to comply with paragraph 2, Conopco agrees to comply with California Health & Safety Code § 25249.6 and 22 CCR § 12601 for (a) each of the

identified in the attached Appendices A and B.

6. The Parties recognize that the Products covered by this Agreement are or may be regulated under federal statutes. Nothing in this Agreement shall be construed to mean that Prop 65 or any of its implementing regulations require the specific warning message or method set forth in this Agreement.

7. In the event that any of the provisions of this Agreement is held by a court to be unenforceable, the validity of the enforceable provisions shall not be adversely affected.

⑧ In the event that (a) it is finally adjudicated by a California court, or (b) AYS resolves its dispute with another defendant, in a manner which provides that certain nail enamel or nail care products containing a certain percentage of toluene as an intended ingredient ("Toluene-containing Products") may be sold in California without the requisite Proposition 65 warning, paragraph 2 hereof shall be modified so as to allow Conopco to ship (or cause to be shipped) into the State of California Toluene-containing Products (i.e., containing at or less than the percentage of toluene permitted for Toluene-containing Products) for sale in California. It is expressly agreed that nothing in this paragraph shall modify any paragraph in this Agreement other than paragraph 2.

⑨ In the event that a dispute arises out of or is in any way connected with any provision(s) of this Agreement, either of the parties' performance obligations under this Agreement, on the subject matter of the Action, the parties agree first to negotiate in good faith a mutually satisfactory resolution of the dispute, and if negotiation fails, then to submit

Products on the attached Appendix A that is shipped for sale by Conopco into California after October 1, 1993, or (b) each of the Products that is shipped by Conopco for sale into California on the attached Appendix B by December 31, 1993, by providing a warning that is: i) prominent and displayed with such conspicuousness, as compared with other words, statements, or designs as to render it likely to be read and understood by an ordinary individual; ii) calculated to warn individuals at the point of purchase as well as individuals who may use the Products at beauty, hair or nail salons; and c) bears the message:

WARNING: Use of this product will expose you to toluene, a chemical known to the State of California to cause birth defects or other reproductive harm.

In addition, if Conopco fails to comply with paragraph 2 by December 31, 1993, Conopco agrees to pay the sum of \$20,000 to AYS by January 1, 1994.

4. In an effort to defray AYS' costs of investigating this matter, Conopco agrees to pay to AYS the reasonable sum of \$46,500.

5. AYS, on its own behalf and on behalf of its subsidiaries, affiliates, successors and assigns and its directors, officers, agents and employees, by this Agreement waives all rights to institute any form of legal action against Conopco, its distributors or retailers which sell the Products, whether under Prop 65, California Business & Profession Code §§ 17200 et seq., or any other statute or common law claim based on Conopco's alleged failure to warn about exposure to toluene from, or their sale of, any of the Products

the dispute to binding arbitration pursuant to the rules of the American Arbitration Association, using a former judge as the sole arbitrator, as selected from those former judges available through the Judicial Arbitration and Mediation Service in San Francisco, California. Should the dispute be submitted to such binding arbitration, the prevailing party in that binding arbitration shall be entitled to recover its costs, including reasonable attorneys' fees and the costs of expert consultants and witnesses.

10. The terms of this Agreement shall be governed by the laws of the State of California.

with prejudice (to be approved pursuant to California Code of Civil Procedure § 664.6) with the San Francisco Superior Court in accordance with the terms set forth in this Agreement.

13. AYS hereby acknowledges that it is aware that it may hereafter discover facts in addition to or different from those which it now knows or believes to be true with respect to the subject matters of this Agreement, but that it is its intention fully, finally and forever to settle any and all disputes and differences, asserted and unasserted, known and unknown, suspected and unsuspected, which now exist, may exist, or have existed, with respect to the matters settled pursuant to this Agreement. In light of the foregoing and in view of the fact that AYS has been advised by its counsel relating to the provisions of § 1542 of the Civil Code of the State of California, AYS specifically waives, to the extent permitted by law, the provisions and the benefits of the provisions of said § 1542, as follows:


"A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM, MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR."

14. The undersigned are authorized to execute this Agreement on behalf of their respective parties and have read, understood and agreed to all of the terms and conditions of this Agreement. This Agreement may be executed in counterparts, by original signature or facsimile transmission of an original signature, each of which shall be deemed

an original and shall be deemed duly executed upon the signing of the counterparts by the Parties. With respect to this Agreement, all agreements, covenants, representations and warranties, express or implied, oral or written, of the Parties concerning the subject matter of this Agreement are contained herein. No other agreements, covenants, representations or warranties, express or implied, oral or written, have been made by any party (or the representative of any party) to any other party (or the representative or agent of any party) concerning the subject matter hereof. All prior and contemporaneous conversations, prior drafts of this Agreement, negotiations, possible and alleged agreements, representations, covenants and warranties concerning the subject matter hereof other than those referred to herein are merged herein and shall not be used to interpret the language and/or meaning of this Agreement. This is an integrated Agreement.
