

TO DEFENDANT ARAMCO IMPORTS, INC:


Plaintiff having presented to the Court sufficient grounds to initiate a contempt proceeding, you are ordered to appear on ~~January 24~~ ^{February}, 2012, at ~~2:30~~ ^{pm} in Department 516 of this Court to show why you should not be held in contempt of this Court's Judgment entered on November 20, 2009, enjoining and restraining you from shipping, selling, or offering to be shipped for sale in California any mugs with colored artwork or designs on the exterior containing less than or equal to 300 parts per million of lead.

IT IS FURTHER ORDERED THAT:

This Order to Show Cause shall be served on defendant by personal service or in some other manner that ensures formal notification of the contempt charge and the time and place of the hearing no later than December ~~30~~, 2011. Proof of such service shall be filed at least 10 court days prior to the hearing. *Plaintiff shall file and serve an application for an order to show cause re: contempt of judgment by January 30, 2012.*

Any opposition papers to the Order to Show Cause shall be filed and served on plaintiff by personal service or overnight transmission no later than ~~February 14~~ ^{14, 2012}. Any reply papers to the opposition shall be filed and served on defendant by personal service or overnight transmission no later than ~~February 20~~ ^{February 20, 2012}. *Courtesy copies of pleadings to be delivered to Dept. 516 on date of filing.*
