1 Pursuant to Code of Civil Procedure section 585, the Court hereby enters final judgment in  
2 favor of plaintiff Russell Brimer against defendant Bam Brokerage, Inc. as follows:

3 1. Pursuant to Health and Safety Code section 25249.7(a), Bam Brokerage, Inc. is  
4 permanently enjoined from offering any folding chairs in travel bags containing lead in California  
5 without providing clear and reasonable warnings regarding the risks of reproductive harm or birth  
6 defects caused by lead exposures. This includes but is not limited to the following products:

11 2. Bam Brokerage, Inc. is ordered to pay \$ ~~2,500~~<sup>ec</sup> in statutory penalties, pursuant  
12 to Health and Safety Code section 25249.7(b);

13 3. Bam Brokerage, Inc. is ordered to pay \$39,466 in attorneys' fees to Brimer as  
14 reimbursement of reasonable attorneys' fees pursuant to Code of Civil Procedure section 1021.5. In  
15 addition, Bam Brokerage is ordered to pay \$ ~~1,128.94~~<sup>\$1,084.82</sup> in costs. *WJM* William J. Monahan

16 4. All amounts required by paragraphs 2 and 3 of this Default Judgment are due within  
17 thirty days of the date of entry of this Default Judgment. These amounts shall be paid to plaintiff's  
18 attorneys by check made payable to "The Chanler Group" and shall be sent to The Chanler Group,  
19 2560 Ninth Street, Parker Plaza Suite 214, Berkeley, California 94710.
