## SETTLEMENT AGREEMENT

## 1. INTRODUCTION

1.1 Parties. This Settlement Agreement is entered into by and between Anthony E. Held, Ph.D., P.E. ("Held") and M.S. Inserts and Fasteners Corp. ("MSIF"), with Held and MSIF each individually referred to as a "Party" and collectively as the "Parties." Held is an individual residing in California who seeks to promote awareness of exposures to toxic chemicals and to improve human health by reducing or eliminating hazardous substances contained in consumer products. MSIF employs ten or more persons and is a person in the course of doing business for purposes of the Safe Drinking Water and Toxic Enforcement Act of 1986, Health and Safety Code section 25249.6 et seq. ("Proposition 65").
1.2 General Allegations. Held alleges that MSIF manufactures, imports, sells, or distributes for sale in the state of California, hand tools with vinyl/PVC grips that contain di(2ethylhexyl)phthalate ("DEHP") and Lead without first providing the clear and reasonable health hazard warning required by Proposition 65. DEHP and Lead are each listed pursuant to Proposition 65 as a chemical that is known to the State of California to cause birth defects and other reproductive harm.
1.3 Product Description. The products covered by this Settlement Agreement are hand tools with vinyl/PVC grips containing DEHP and/or Lead that are manufactured, sold, or distributed for sale in California by MSIF, including, but not limited to, the ROLA M.O.V.E. Organizer, \#59001 (UPC No. 04289959001 9) (collectively, "Products").
1.4 Notice of Violation. On October 30, 2013, Held served MSIF and the requisite public enforcement agencies with a 60-Day Notice of Violation ("Notice"), alleging that MSIF violated Proposition 65 when it failed to warn its customers and consumers in California that the Products expose users to DEHP and Lead. To the best of the Parties' knowledge, no public enforcer has commenced and is diligently prosecuting the allegations set forth in the Notice.
1.5 No Admission. MSIF denies the material, factual, and legal allegations contained in the Notice and maintains that all of the products it has manufactured, sold, or distributed for sale in California, including the Products, have been, and are, in compliance with all laws. Nothing in this Settlement Agreement shall be construed as an admission by MSIF of any fact, finding, conclusion of law, issue of law, or violation of law; nor shall compliance with this Settlement Agreement constitute or be construed as an admission by MSIF of any fact, finding, conclusion of law, issue of law, or violation of law, the same being specifically denied by MSIF. This section shall not, however, diminish or otherwise affect MSIF's obligations, responsibilities, and duties under this Settlement Agreement.
1.6 Effective Date. For purposes of this Settlement Agreement, the term "Effective Date" shall mean February 1, 2014.

## 2. INJUNCTIVE RELIEF: REFORMULATION \& INTERIM WARNINGS

2.1 Reformulated Products. Commencing on the Effective Date and continuing thereafter, MSIF shall only manufacture, ship, sell, or distribute for sale in California, Reformulated Products. For purposes of this Settlement Agreement, "Reformulated Products" are Products with grips that contain: (a) a maximum DEHP concentration of 1,000 parts per million ("ppm") ( $0.1 \%$ ) when sampled analyzed pursuant to U.S. Environmental Protection Agency ("EPA") testing methodologies 3580A and 8270C; and (b) a maximum lead concentration of 90 parts per million ("ppm") $(0.009 \%)$ when sampled and analyzed pursuant to EPA testing methodologies 3050B and 6010B. In addition to the EPA methodologies authorized by this Section, the Parties may use equivalent methodologies utilized by state and federal agencies to measure lead or phthalate content in a solid substance, to determine the DEHP and/or lead content of the Products.
2.2 Reformulation Commitment. As of the Effective Date all Products imported, distributed, sold, or offer for sale in the State of California by MSIF shall be Products that qualify as Reformulated Products as defined in Section 2.1 above, or shall carry the Proposition 65 warnings specified in Section 2.3 below.
2.3 Interim Product Warnings. For all Products other than Reformulated Products, MSFI agrees that it will only sell or distribute such Products for sale in California with a clear and reasonable warning in accordance with this Section. MSFI shall affix the warning directly to the Product, or on Product packaging or labeling, if any. The warning shall be prominently placed with such conspicuousness as compared with other words, statements, designs, or devices as to render it likely to be read and understood by an ordinary individual under customary conditions before purchase or use. Any warning MSFI elects to employ shall be provided in a manner such that the consumer or user understands to which specific Product the warning applies, so as to minimize the risk of confusion.

A warning provided under this Settlement Agreement shall contain the following statement:

> WARNING: This product contains Lead and DEHP, chemicals known to the State of California to cause birth defects or other reproductive harm.

## 3. MONETARY SETTLEMENT TERMS

3.1 Civil Penalty Payments. Pursuant to Health and Safety Code section 25249.7(b), MSIF shall pay $\$ 6,000$ in civil penalties. Each penalty payment shall be allocated according to Health and Safety Code section 25249.12(c)(1) and (d), with $75 \%$ of the penalty amount paid to the California Office of Environmental Health Hazard Assessment ("OEHHA") and the remaining $25 \%$ of the penalty paid to Held.
3.1.1 Initial Civil Penalty. Within fifteen days of the Effective Date, MSIF shall make an initial civil penalty payment of $\$ 2,000$. MSIF shall provide its payment in two checks for the following amounts made payable to: (a) "OEHHA" in the amount of $\$ 1,500$; and (b) "The Chanler Group in Trust for Anthony E. Held" in the amount of $\$ 500$.
3.1.2 Final Civil Penalty. On or before June 15, 2014, MSIF will make a final civil penalty payment of $\$ 4,000$. Pursuant to title 11 California Code of Regulations section 3203(c), the final civil penalty payment will be waived in its entirety if, no later than June 1,

2014, an officer of MSIF certifies in writing to Held's counsel that, as of such date, onehundred percent (100\%) of the Products MSIF manufactures for sale or purchases for sale in California are Reformulated Products as defined by Section 2.1, and that MSIF will continue to only offer Reformulated Products in California in the future. The option to certify timely reformulation in lieu of making the final civil penalty payment constitutes a material term of this Settlement Agreement, and with regard to such term, time is of the essence. Unless waived, final civil penalty payments to Held and OEHHA shall be delivered to the addresses provided in section 3.3.
3.2 Attorney Fees and Costs. The Parties reached an accord on the compensation due to Held and his counsel under general contract principles and the private attorney general doctrine codified at Code of Civil Procedure section 1021.5 for all work performed in this matter. Under these legal principles, MSIF shall pay $\$ 17,500$ for all fees and costs incurred investigating, bringing this matter to the attention of MSIF's management, and negotiating a settlement in the public interest. Payment shall be delivered in seven separate checks made payable to "The Chanler Group in Trust" due on the $15^{\text {th }}$ of each month from February 15, 2014, through August 15, 2014. MSIF agrees, however, that, in the event it fails to make any payment required by this Settlement Agreement, or any payment is delayed by more than ten days, all amounts owed will become due immediately.
3.3 Payment Procedures. With the exception of the final civil penalty payment required by Section 3.1.2, all payments owed under this Settlement Agreement are due within five days of the Effective Date and to be delivered according to the following subsections:

3.3.3 Copy of Payments to OEHHA. MSIF agrees provide Held's counsel with a copy of the checks to OEHHA enclosed with its settlement payments to Held, and delivered to address provided in Section 3.3.1.
3.3.4 Tax Documentation. For the payments made under this Settlement Agreement, MSIF agrees to provide a completed IRS 1099 form for each of the following payees:
(a) "Anthony E. Held" whose address and tax identification number shall be provided after this Settlement Agreement is fully executed by the Parties;
(b) "The Chanler Group" (EIN: 94-3171522) at the address provided in section 3.3.1; and
(c) "Office of Environmental Health Hazard Assessment" (EIN: 68-0284486), 1001 I Street, Sacramento, CA 95814.

## 4. CLAIMS COVERED AND RELEASED

4.1 Held's Release of MSIF. This Settlement Agreement is a full, final, and binding resolution between Held and MSIF of any violation of Proposition 65 that was or could have been asserted by Held, on behalf of himself, or on behalf of his past and current agents, representatives, attorneys, successors, and assignees, against MSIF, its parents, subsidiaries, affiliated entities under common ownership (including without limitation Thread Kits Company), its directors, officers, employees, attorneys, and each entity to whom MSIF directly or indirectly distributes or sells the Products, including, without limitation, its downstream distributors, wholesalers, customers, retailers, franchisees, cooperative members, and licensees ("Releasees"), based on unwarned exposures to DEHP from Products manufactured, sold or distributed for sale in California by MSIF prior to the Effective Date.

In further consideration of the promises and agreements herein contained, Held, on his own behalf and on behalf of his past and current agents, representatives, attorneys, successors, and/or assignees, hereby waives all rights to institute or participate in, directly or indirectly, any form of legal action, and releases all claims that he may have against MSIF and Releasees, including, without limitation, all actions and causes of action, suits, liabilities, demands, obligations, damages, costs, fines, penalties, losses, or expenses, including, without limitation, investigation fees, expert fees, and attorneys' fees arising under Proposition 65 for unwarned exposures to DEHP from Products manufactured, sold, or distributed for sale in California by MSIF prior to the Effective Date.
4.2 MSIF's Release of Held. MSIF, on its own behalf and on behalf of its past and current agents, representatives, attorneys, successors, and assignees, hereby waives any and all claims that it may have against Held and his attorneys and other representatives, for any and all actions taken or statements made (or those that could have been taken or made) by Held and his attorneys and other representatives, whether in the course of investigating claims, otherwise seeking to enforce Proposition 65 against it in this matter, or with respect to the Products.

## 5. POST EXECUTION CONVERSION TO CONSENT JUDGMENT

Within twelve months of the execution of this Settlement Agreement, MSIF may request in writing that Held draft and file a complaint, incorporate the terms of this Settlement Agreement into a proposed consent judgment providing a release for the Products in the public interest, and seek court approval of the consent judgment pursuant to Health and Safety Code section $25249.7(\mathrm{~d})$, or as may be otherwise allowed by law. If requested, Held and MSIF agree to reasonably cooperate and to use their best efforts, and those of their counsel, to obtain an entry of judgment in accordance with the terms of this Settlement Agreement by a superior court in California in a timely manner.

Pursuant to Code of Civil Procedure sections 1021 and 1021.5, if so requested, MSIF agrees to reimburse Held and his counsel for the reasonable fees and costs incurred in connection with work performed pursuant to this section in an amount not to exceed $\$ 8,000$, exclusive of fees and cost on appeal, if any. Within ten days of receiving an invoice from Held's counsel for work performed under this section, MSIF will remit payment to the address provided in section 3.3.1.

## 6. SEVERABILITY

If, subsequent to the execution of this Settlement Agreement, any provision of this Settlement Agreement is held by a court to be unenforceable, the validity of the remaining provisions shall not be adversely affected.

## 7. GOVERNING LAW

The terms of this Settlement Agreement shall be governed by the laws of the state of California and apply within the state of California. In the event that Proposition 65 is repealed or is otherwise rendered inapplicable by reason of law generally, or as to the Products, then MSIF may provide written notice to Held of any asserted change in the law, and have no further obligations pursuant to this Settlement Agreement, with respect to, and to the extent that, the Products are so affected.

## 8. NOTICE

Unless specified herein, all correspondence and notices required to be provided pursuant to this Settlement Agreement shall be in writing and sent by: (i) personal delivery; (ii) first-class, registered or certified mail, return receipt requested; or (iii) a recognized overnight courier on any Party by the other at the following addresses:

This Settlement Agreement may be executed in counterparts, and by facsimile or portable document format (PDF) signature, each of which shall be deemed an original, and all of which, when taken together, shall constitute one and the same document.

## 10. POST-EXECUTION ACTIVITIES

Held agrees to comply with the reporting form requirements referenced in Health and Safety Code section 25249.7(f).

## 11. DISMISSAL OF THREAD KITS COMPANY

Within five days of receiving the initial fee and penalty payments required by Sections
3.1.1 and 3.2, Held agrees to file a dismissal without prejudice of the action pending against Thread Kits Company Held v. Threat Kits Company, et al. San Francisco Superior Court, Case No. CGC-13-534148.

## 12. MODIFICATION

This Settlement Agreement may be modified only by a written agreement of the Parties.

## 13. AUTHORIZATION

The undersigned are authorized to execute this Settlement Agreement on behalf of their respective Parties and have read, understood and agree to all of the terms and conditions of this Settlement Agreement.
